In the event of any discrepancies, this T&C shall prevail over the TM's Website T&C but only to the extent of such discrepancies only. Other terms that are not affected shall remain as is. TM reserves the right to vary, supplement, delete, amend or modify this T&C, from time to time without prior notice to you. By subscribing to unifi eBiz Plan, You are deemed to have read, understood and agree to be bound by the terms and conditions herein and further agree that any decision by TM in relation to every aspect of the plan, shall be final, binding and conclusive.
